Outplacement Practicum Process

Outplacement practicum provides an exciting opportunity to receive clinical training in various organizations. Please note that all practicums are arranged by the practicum coordinator, Nicolas Guerda. This brochure is meant to provide an initial introduction to sites approved by the faculty in the community. If you are interested in a site not listed, please contact Dr. Nicolas (nguerda@miami.edu) for further discussion. The information contained in this brochure has been provided by the training director at each site. The sites listed are those that we often work with to place students.

Application Process

Each site has a different application process and deadline for the materials required. Once you decide where you would like to apply, please contact the outplacement practicum coordinator and she will inform you of the next step. Generally, the outplacement practicum coordinator organizes a list of students interested in each site and forwards this to the training director of the practicum. All instructions will be provided by the coordinator of outplacement practicum. No student is to contact a site prior to a discussion with the UM faculty member in charge of coordinating practicums. In the meantime, it is important that you update your CV and think about what skills you want to highlight in an email or cover letter that you send the training director at each practicum site.

When you apply to the practicum site, please be sure to email the site contact person and CC the outplacement program coordinator.

Selection Process

The selection process varies for each site. Most require an in-person interview after they have reviewed your application material. You will be informed directly by the site whether or not they have accepted you for training.

Time Commitment

Most practicum sites require a commitment of 11-12 months. A few sites might consider a student for less time. Sites will usually ask for a weekly time commitment of 18-20 hours per week. However, this also varies by site.

Supervision Requirements

All students participating in outplacement practicum are required to receive weekly one-hour supervision by a licensed psychologist or licensed mental health counselor at the training organization. Additional supervision in the form of individual or group may also be provided by the site. This varies by site, and the student is encouraged to discuss this with the site prior to committing to the site.

CPY Program Requirements

In order to participate in outplacement experience, there are several requirements.

- (1) You must register for at least three credits of EPS 682 Practicum Seminar **AND** two credits of EPS683 Masters Outplacement Practicum. At the end of your practicum training, you need to have accrued a minimum of 9 credit hours of EPS 682 Practicum Seminar AND 6 credit hours of EPS 683, for a total of 15 hours for your practicum training.
- (2) You must **purchase student liability insurance** to cover at least \$1M each incident/ \$3M annual aggregate (the typical standard professional liability insurance for students).
- (3) You must **purchase Time-To-Track** for the length of your outplacement experience, as you will be required to document your hours and submit summary sheets on a monthly basis logging your hours. You will also be required to submit a Time-To-Track at the end of each semester, that is signed by your supervisor. At the end of the practicum, you **MUST HAVE** accrued a **minimum of 700 total hours** of supervised clinical experience, of which you must have a **minimum of 280 direct client contact hours** completed. Time-to-track sheets, signed by your supervisor, must be submitted at the end of each semester in order for you to receive your grade. This is attached to your semester evaluation.
- (4) **You** are responsible for ensuring that you and your supervisor submit the supervisor's evaluation of you by the date specified by the practicum coordinator so that you may receive a grade for your outplacement practicum experience.
- (5) At the end of your outplacement experience, you are asked to submit an evaluation of your supervisor and of your overall experience at the outplacement. This information will be used to advise future students of outplacement opportunities, as well as help with the evaluation of site continuation.
- (6) Additional requirements may exist for international students related to immigration documents.

Site Specific Requirements

Several sites have their own requirements prior to beginning outplacement. This may include, but is not limited to, fingerprinting, proof of immunization, a doctor letter of good health, and drug testing. If the site does not cover the expenses incurred for these requirements, it is the responsibility of the student to cover any, and all, expenses related to these requirements.

BRIEF DESCRIPTION OF PROGRAM

Description	The Child and Adolescent Mood and Anxiety Treatment (CAMAT) program in the Department of Psychology at the University of Miami is a clinical research program dedicated to developing and testing state-of-the-art psychotherapy approaches for anxiety and depression in children and adolescents. We are a welcoming environment for diverse youth and families. Some of our programs are funded by research grants that allow us to provide diagnostic assessments and evidence-based treatment to children and adolescents at low- to no-cost. CAMAT also provides training to students and therapists learning how to apply our treatments, which feature novel intervention models like the Unified Protocols for Transdiagnostic Treatment of Emotional Disorders in Children and Adolescents and the Comprehensive Behavioral Intervention for Tics. The majority of our treatments have a substantial exposure therapy component and are tailored to fit the individual, family and community context. Interest in learning to deliver evidence-based treatments for youth with excellence and some prior experience working with children is preferred. We welcome and appreciate Spanish-speaking students, but this is not required.

BRIEF DESCRIPTION OF PROGRAM

Description	<p>The Children's Bereavement Center (CBC) provides free peer support groups for children and families after loss. Families are referred to our program through various community resources (school, clergy, mental health providers, pediatricians, hospitals, hospice...) and must attend a brief Orientation to our program prior to participating in groups.</p> <p>With locations in Coconut Grove, Miami Shores and Ft. Lauderdale we are able to support grieving families as they integrate loss in to their lives. In addition to providing support for children and families, our "Lift From Loss" programs offer the same model of peer support for young adults, age 18-35, at Hillel on the UM campus and for older adults (without school age children) at Temple Judea in Coral Gables.</p> <p>Our model of utilizing attachment theory focuses on providing children, teens, young adults, parents and caregivers a safe environment where their experience of loss is normalized thereby allowing them to safely explore their new world and regain confidence and hope in the future.</p> <p>Children, teens and young adults are in groups of same-age participants while their parents/caregivers attend groups of their own at the same time. The range of issues and feelings are explored as participants are free to share or simply listen to others whose experience may allow them a gauge to their own thoughts and feelings.</p> <p>The CBC is not therapy or counseling. The CBC provides a safe place for families to share with others who support and mentor one another through one of the most difficult times in their lives.</p>

BRIEF DESCRIPTION OF PROGRAM

Description	<p>The CIFFTA Adolescent and Family Indicated Prevention Program: A UM and Community Partnership to help at-risk adolescents realize a healthy and successful future. The UM team will work closely with long-time partners such as the Juvenile Services Department, Child Welfare, and Natural Helpers to identify youth showing behavioral, mental health, family, and school-related problems. CIFFTA is culturally-informed and trauma-informed intervention that is tailored to unique strengths and risk factors.
